SOCAR, Petronas mull partnership ties SOCAR President Rovnag Abdullayev has

The sides discussed the current partnership between the companies, including development of Shah Deniz project.

Tan Sri Wan Zulkiflee Bin Wan Ariffin described such meetings as beneficial and shared his views on holding another meetings in Baku and Malaysia in the years to come.

Assets of SOFAZ exceed \$40 billion

Celebrating its 20th anniversary this year,



the assets of the State Oil Fund of the Republic of Azerbaijan (SOFAZ), established as a

result of the foresighted decision of national leader Heydar Aliyev, have increased to over \$40 billion for the first time in its history. The growth of SOFAZ's assets demonstrates the successful implementation of a policy aimed at achieving a sustainable long-term economic growth, through significant socioeconomic reforms pursued by President Ilham Aliyev.

Budget revenues of SOFAZ for the period of January-March, 2019, reached 5 960.7 million manats, while budget expenditures 2 640.7 million manats. Revenue of 4 605.0 mln. manats was received from implementation of oil and gas agreements, including 3 833.5 mln. manats from the sale of profit oil and gas, 766.4 mln. manats as bonus payments and 5.1 mln. manats as transit payments.

The revenues from managing SOFAZ's assets for January-March, 2019, amounted to 1 355.7 mln. manats.

As per 2019 budget of the Fund, 2 615.0 mln. manats were transferred to the state budget. The expenditures in the amount of 19.7 mln. manats were directed to financing the improvement of social-economic condition of refugees and internally displaced persons. SOFAZ's administrative and operational expenses for the reporting period were 6.0 mln. manats.

SOFAZ's extra-budgetary expenditures related to the revaluation of foreign exchange totaled 332.0 mln. manats.

The assets of SOFAZ as of March 31, 2019, have increased by 4.56% compared to the beginning of 2019 (USD 38 515.2 mln.) and stood at USD 40 273.3 mln. The increase was mainly due to SOFAZ budget revenues and asset management activity.

TAP project 86.5% completed

The Trans Adriatic Pipeline (TAP) project, which envisages transportation of



Azerbaijani gas to Europe, is 86.5 percent complete as of late March, the TAP AG company reports.

"TAP is currently moving further into the project construction phase. Every day hundreds of meters of TAP's Right of Way (ROW) are cleared, strung, welded, lowered into the trenches and backfilled, in line with the project construction steps and schedule," said a message from the consortium.

TAP project, worth 4.5 billion euros, is one of the priority energy projects for the European Union (EU). The project envisages transportation of gas from Azerbaijan's Shah Deniz Stage 2 to the EU countries.

Connecting with the Trans Anatolian Pipeline (TANAP) at the Greek-Turkish border, TAP will cross Northern Greece, Albania and the Adriatic Sea before coming ashore in Southern Italy to connect to the Italian natural gas network.

TAP's shareholding is comprised of BP (20%), SOCAR (20%), Snam S.p.A. (20%), Fluxys (19%), Enagás (16%) and Axpo (5%).

4th SOCAR Forum kicks off in Baku

Trading, Logistics, Refining, Petrochemicals has got underway in Baku. Addressing the event, Minister of Energy of Azerbaijan Parviz Shahbazov, Minister of Ecology and Natural Resources Mukhtar Babayev, First Vice-President of SOCAR Khoshbakht Yusifzade, Vice President for Communications, External Affairs, Strategy & Region at BP Azerbaijan-Georgia-Turkey Bakhtiyar Aslanbayli, Rector of Baku State University Elchin Babayev and Director of Communications at UkrGazVydobuvannya Volodimir Gaidash shared their views about the Forum.

Convened annually since 2016, this year's brings together nearly Forum 300 participants from over 20 countries and top managers from the leading national and overseas companies and fuel-energy, petrochemical and logistics facilities in the Caspian region and Central Asia as well as relevant forefront experts. analysts. representatives from the diplomatic corps, and a wide range of other specialists. The Forum offers participants the opportunity to gain insights into the prospects of oil & gas industry development in Azerbaijan, oil & gas markets in the Caspian region and Central Asia, hydrocarbon logistics and transit potential, major export routes, crude and products trade flows, modernization of the refineries and petrochemical plants, innovative technologies in the oil & gas and industry, explore various other observations and expert opinion.

Equinor invests in new platform in Azerbaijan

Equinor and eight partners in the offshore Azeri Chirag Gunashli (ACG) oilfield in the



Caspian Sea have made a \$6 billion investment decision to build an additional platform in the

license area, according to the World Oil magazine.

The investment decision follows an agreement with the Government of Azerbaijan to extend the life of the ACG field until 2049.

The new platform, called ACE (Azeri-Central-East), will be integrated with existing infrastructure. It is designed to process up to 100,000 bopd and expected to produce up to 300 MMbbl over its lifetime. Equinor holds a 7.27% share in the oilfield and first oil is expected in 2023. "Equinor has been creating significant value in Azerbaijan over many years, and we are excited to reach this milestone. Together with operator BP we are eager to contribute to safe operations that will provide cash flow to Equinor for many years," says Torgrim Reitan, executive V.P. for Development & Production International (DPI) in Equinor.

The main objectives of the platform are to add drilling capacity to both accelerate production and increase recovery and reduce risk. In addition, the platform provides flexibility for hosting future developments in ACG. In a departure from previous projects, the drilling facilities will be fabricated entirely in Azerbaijan alongside the topsides to leverage the track record and skillset built in the Caspian.

In addition to the ACG ACE decision Equinor is pursuing other opportunities in Azerbaijan. Equinor and partner SOCAR are planning to drill an appraisal well later this year in the Karabagh license, a discovery from 2000. Following the drilling in Karabagh, the plan is to drill the Aypara exploration well in the Ashrafi, Dan Ulduzu, Aypara licence.

"Equinor had an average daily equity production of 854,000 bpd outside Norway in the fourth quarter of 2018. We want to grow internationally, take on more operatorships and seek growth options. Azerbaijan is an important country for Equinor and over the last few years we have been able to develop new growth opportunities in the region. The decision to add one platform to the ACG field is contributing to Equinor's international strategy," says Reitan.

ACG currently has eight offshore platforms – six production platforms and two process, gas compression, water injection and utilities platforms. The platforms export oil and gas to the Sangachal Terminal, one of the world's largest oil and gas terminals, onshore near Baku. In 2018, total production from ACG averaged 584,000 bpd, of which Equinor has an equity production of approximately 43,000 bpd. Equinor has been in Azerbaijan since 1992. ACG participating interests are: BP (30.37%), SOCAR (25.0%), Chevron (9.57%), INPEX (9.31%), Equinor (7.27%), ExxonMobil (6.79%), TPAO (5.73%), ITOCHU (3.65%), ONGC Videsh Limited (OVL) (2.31%).

Heydar Aliyev rig drills deepest well in Caspian Sea

6th generation semi-submersible drilling rig



Heydar Aliyev under Caspian Drilling Company's (CDC) management sat Caspian Sea record

while drilling ABD-001 well on Absheron field where JOCAP (Joined Operating Company Absheron Petroleum a JV SOCAR Absheron 50% - TOTAL E&P Absheron 50%) is operator.

On April 15 at 13:00 the well has reached 7411m TMD (total measured depth), it is a deepest well ever drilled on Caspian Sea.

The rig was built and commissioned at Caspian Shipyard in 2017 under CDC management and named in honor of Azerbaijani national leader Heydar Aliyev. This is the first well in progress ever drilled by semi-submersible rig Heydar Aliyev.

Azercosmos provided satellite and telecom services to 17 countries in Q1 of 2019

Azercosmos` satellite and telecommunication services were exported



to 17 countries in the first quarter of 2019, according to the April 2019 issue of "Export Overview" of the Center for

Analysis of Economic Reforms and Communications.

"Azercosmos` revenues from commercial operation of the satellite and telecom services amounted to \$5,5 million in January-March, 2019. The company`s revenues from export of services in Q1 accounted for 85% of its total revenues," said the report.

Main consumers of Azercosmos` services are the US, France, the UAE, Germany and the United Kingdom.
