### OIL & GAZ

#### European Commission allocates €5m grant for TANAP project

The European Commission (EC) has allocated a grant worth 5 million euros for the Trans Anatolian Natural Gas Pipeline (TANAP) project, which is part of the Southern Gas Corridor, envisaging transportation of Azerbaijani gas to Europe, said a message from TANAP consortium. The grant will be allocated under the EC's Connecting Europe Facility (CEF) Energy Work Program.

European Union countries have undertaken to invest a total of 48.4 million euros in infrastructure projects and TANAP has been one of the two natural gas projects selected for financial support under the program's first call for proposals," said the consortium.

TANAP, together with Trans-Adriatic Pipeline (TAP), is a part of the Southern Gas Corridor, which provides for the

transportation of gas from the Azerbaijani field Shah Deniz to Europe.

The share distribution in TANAP is as follows: Southern Gas Corridor CJSC - 51 percent, SOCAR Turkey Enerji - 7 percent, Botas - 30 percent, and BP - 12 percent.

#### Energy minister: Azerbaijan ready to share its energy experience with the African Union countries

"Azerbaijan is ready to share its energy



experience with the countries of the African Union," said Azerbaijan's Minister of Energy Parviz Shahbazov as he met with a delegation led by Commissioner for Infrastructure, Energy, ICT, and tourism at the African Union Commission Amani Abou-Zeid.

Shahbazov highlighted Azerbaijan's road to success as an oil and gas country. He spoke about the role of Azerbaijan in implementing global energy projects.

The minister said Azerbaijan enjoys high potential in the field of renewable energy

sources, adding that consultations with international companies are underway to realize this potential.

Abou-Zeid outlined the priorities of the African Union Commission regarding the energy sector. She took interest in Azerbaijan's experience in all aspects of the energy sector.

### **SOCAR AQS, KCA Deutag to sign joint venture contract**

Azerbaijan's SOCAR AQS LLC and KCA Deutag, one of the world's leading drilling and engineering contractors, will sign a joint venture (JV)



contract, according to the SOCAR AQS LLC. The signing ceremony will be held on July 26 in Baku. The contract envisages drilling and rendering maintenance services for seven BP platforms at the Central Azeri, East Azeri, West Azeri, Chirag and West Chirag, Deepwater Gunashli and the Shah Deniz gas condensate field.

KCA Deutag has been operating in Azerbaijan since 1995. The head office of the company is located in Aberdeen, UK. SOCAR-AQS LLC was established as an integrated drilling and well services management company between the State Oil Company of Azerbaijan Republic (SOCAR) and Absheron Drilling Company (AQS) in 2007. ### **SOCAR: Kulevi Port received more than 2,200 vessels**

The port of Kulevi oil terminal of SOCAR's asset in Georgia, so far, has received and departed more than 2,200 vessels.



Kulevi Port began operating in May 2008. Since then, the port has received and departed more than 2,200 vessels. The port operates without interruption year. One of the most important factors in Kulevi Port's

successful functioning is maintaining navigation depths at the access channel and its internal harbor. The total capacity of the terminal is 10 million tons of oil cargo per year, including three million tons of oil, three million tons of diesel fuel and four million tons of fuel oil.

The total capacity of the terminal's tank farm is 320,000 cubic meters.

### **To date 53 billion cubic meters of Azerbaijani gas delivered to Turkey by Shah Deniz-1**

Over 94 billion cubic meters of natural gas



has been extracted from the Shah Deniz gas field in the Azerbaijani sector of the Caspian Sea since

going into service, said first vice president of Azerbaijan's state oil firm, SOCAR, Khoshtakht Yusifzade.

According to Yusifzade, to date over 53 billion cubic meters of Shah Deniz gas were exported to Turkey, while 7.3 billion cubic meters to Georgia by the South Caucasus Pipeline (SCP).

### **Baku to host meeting of Board of Directors of Arab Petroleum Investments Corporation**

"The Board of Directors of Arab Petroleum

(APICORP) will held its next meeting in

Baku," said Azerbaijan's Deputy Minister of Energy Samir Valiyev as he met with a delegation led by Deputy Minister of Energy, Industry and Mineral Resources of the Kingdom of Saudi Arabia Aabed bin Abdulla Al-Saadoun.

Valiyev emphasized the importance of developing bilateral cooperation in the field of alternative and renewable energy sources, alongside the oil and gas sector. He said that work is under way to ensure participation of foreign investors in this process and study the international experience.

Saudi minister Abdulla Al-Saadoun hailed collaboration between APICORP and Azerbaijan's State Oil Company (SOCAR) as active and highlighted joint projects. He noted that the next meeting of APICORP Board of Directors will be held in Baku, adding that such events will contribute to the opening of new opportunities of cooperation between the organization and Azerbaijan.

### **1,500 delegates to attend "Caspian Energy Forum Baku– 2018"**

Over 1,500 delegates from 50 countries around the world will take part in the 7th International "Caspian Energy Forum Baku– 2018", First Deputy Chairman and Chief



Executive Officer of the Caspian European Club Telman Aliyev said.

Caspian Energy Forum Baku– 2018 will be held on September 19-20 with the support of the Government of the Azerbaijan Republic and Caspian European Club.

### **Over 1.3 million tourists visited Azerbaijan in the first half of this year**



A total of 1,323,303 foreign tourists visited Azerbaijan in the first half of this year, according to

the State Tourism Agency.

Russia accounts for nearly one third (403,549) of the tourist flow to Azerbaijan in the six months period. Nearly a quarter million (279,102) tourists came from Georgia, while 146, 000 from Iran and 142,476 from Turkey. The country also was a popular destination for tourists from the UAE, Ukraine, Iraq, Kazakhstan, Kuwait, the United Kingdom, Israel, India, Pakistan, Turkmenistan and Qatar.

### Azerbaijan's trading house opens in Latvia
